ELIGIBILITY FOR TAKING THE MEMBERSHIP EXAMINATION OF HONG KONG INTERCOLLEGIATE BOARD OF SURGICAL COLLEGES

MEMBERSHIP EXAM PART 3 (OSCE)

To be eligible for sitting Membership Exam of Hong Kong Intercollegiate Board of Surgical Colleges Part 3, applicants should fulfill the following requirements:

For local applicants:

1. Having **full registration with the Hong Kong Medical Council** (i.e. either possesses a primary medical qualification from The University of Hong Kong or The Chinese University of Hong Kong as prescribed by HKICBSC, OR pass the Licensing Examination of the Medical Council of Hong Kong.).

For Mainland China applicants:

2. Must be trainees from Mainland China training centres accredited by the constituent Colleges of HKICBSC (provided that they undergo such training at the time of or after the relevant accreditation)

For both local and Mainland China applicants:

3. Having **successfully passed** Part 1 and Part 2 of the Examination;
4. Having started Basic Surgical Training (BST) within a **period of 3 years** immediately after the date of publication of the result of having passed the Part 1 or Part 2 (whichever is taken later in time) of the Examination;
5. Being **trainees undergoing BST** in Hong Kong or undergoing BST in the training program accredited by the constituent Colleges of HKICBSC in Mainland China;
6. Having undergone BST for **no less than 6 months** counting up to the day immediately preceding the first day of the Part 3 Examination;
7. Applicant's training should **not be suspended within 6 months** prior to the examination;
8. For Basic Surgical Trainees, they should have paid their registration fee of the exam year and those in arrears before being allowed to take the examination.

All applicants must submit the following documents together with the Application Form in order to complete the application process:

- ✓ **Certified True Copy of Qualification (For both local and Mainland China applicants)**
 - **Primary medical qualification** from The University of Hong Kong or The Chinese University of Hong Kong or **examination result** of the Licensing Exam of the Medical Council of Hong Kong, which are verified by medical or university official, OR a public notary, OR solicitor/lawyer, should have an official stamp accompanying the signature (For **Mainland China Applicants**, they should submit certified true copies of primary medical qualification, which are verified by medical official of Mainland China training centres accredited by the constituent Colleges of HKICBSC, OR a public notary, OR solicitor/lawyer, should have an official stamp accompanying the signature.); OR
- ✓ **Two** certified recent passport photograph with the official stamp and signature by medical or university official
- ✓ **A crossed cheque or bank draft of full payment** made payable to “The College of Surgeons of Hong Kong LIMITED” OR payment in telegraph transfer with bank Administrative Charge required) (Please notify the College in advance).
